Project Objectives

This research will enable the Department of Labour and Advanced Education to adapt the Program as necessary to better meet the needs of employers and to ensure their participation in apprenticeship training. Specifically, the survey findings will give the Department the required information to:

- ✓ Support efforts to effectively measure the performance of the Program in meeting the labour market-related needs of employers; and
- ✓ Guide policy and decision making to increase employer participation and satisfaction in apprenticeship.



Methodology

- ✓ Data collected from a random sample of 500 employers of apprentices in Nova Scotia.
- ✓ Dates of telephone interviewing: January 22 February 13, 2014.
- ✓ The overall margin of error for a sample of 1,873 employers is +/3.8 percentage points, 19 times out of 20.




Most employers are satisfied with the technical training that apprentices receive.

Overall Satisfaction with Technical Training Received by Apprentices






Most employers are satisfied with the experience of being an employer of apprentices, although finding apprentices presents a challenge for some employers.

Overall Opinion of Experience of Being an Employer of an Apprentice






Employers are satisfied with the customer service they receive from the Apprenticeship Training Division.

Overall Satisfaction with Customer Service of the Apprenticeship Training Division



Assessment of Interactions with Apprenticeship Training Division and its Customer Service








There is extensive awareness among employers of their own roles and responsibilities as an employer in the Nova Scotia apprenticeship training system.




Employers largely know how to get information about the ATD, and use a variety of sources to do so, with the ATD training officer and the office itself being most widely consulted.








Apprenticeship Employer Profile


Length of Time Your Organization Has Been Hiring Apprentices
